



ATTENTION: VILLAS RESIDENTS, FAMILY MEMBERS AND TEAM MEMBERS

IMPORTANT – 11/30/2020 COVID-19 UPDATE – *please read this in its entirety.*

In accordance with shared recommendations for the Centers for Disease Control, Centers for Medicare and Medicaid Services, the Pennsylvania Department of Health and others, we are required to notify you each time there is a change or development in our Covid-19 status, including new cases among residents and/or team members. We are also required to notify you if we admit a resident with a Covid-19 diagnosis even if they have met the criteria for discontinuation of transmission-based precautions.

We have received the majority of our results back for our residents and our team members from testing that began on November 21, 2020. In an effort to help identify cases quicker, we administered screening testing again on all residents November 25, 2020 and we have started to receive some of those results as well. We will continue to perform screening testing on residents more frequently than weekly. Team member testing commenced again today. We are moving towards widespread screening testing of team members to take place at least weekly and it will be administered at various times throughout the week going forward. In addition to our ongoing screening testing, we continue to test residents who present symptoms consistent with Covid-19 and request staff consult with their clinician in the event they present with symptoms.

Since our last bulletin, we received notification that seven new residents have tested positive and no new team members tested positive for Covid-19. The residents and their responsible parties were immediately notified verbally of these diagnoses.

Since this outbreak began on November 12, 2020 we have had a total of 32 residents and 18 team members at the Villas test positive for Covid-19. In addition, we have also admitted one resident who has met the criteria for discontinuation of transmission-based precautions.

Any resident that has tested positive and remains in our care resides in one of our designated “Red Zone” neighborhoods. “Red Zone” neighborhoods are Orchards A and one half of the Meadows, which was isolated off last week in anticipation of becoming a “Red Zone.” Here, residents may receive proper care and minimize the risk of further exposure to others who are not positive.

We continue to be vigilant as a community and a team in our efforts to minimize the spread of Covid-19 and while we are experiencing positive cases in residents and team members,

we are still very proud of our team and our residents for doing their best to minimize case numbers in a period of high community transmission; data estimates that 1-in-10 people in our region currently have Covid-19.

All other resident neighborhoods continue to follow “Yellow Zone” protocols, a measure required to be taken when a potential exposure exists.

Please review our website for further information regarding procedures already in place due to positive Covid-19 cases. Please keep those impacted by Covid-19 in your thoughts and prayers.
